4. First aid measures

General information:	Take off immediately all contaminated clothing.

6. Accidental release measures

- Personal precautions:** Provide adequate ventilation. Do not breathe gas/vapor/spray. Avoid contact with skin and eyes. Eliminate all ignition sources if safe to do so. Wear appropriate protective equipment. Be aware that gases can spread at ground level (heavier than air) and pay attention to the wind direction. Take off immediately all contaminated clothing. Keep unprotected people away. Do not open or incinerate, even when empty. Do not spray into flames or on incandescent objects. Cordon off downwind area at risk and warn inhabitants.
- Environmental precautions:** Do not allow to enter into ground-water, surface water or drains. In case of release, notify competent authorities. Danger of explosion!
- Methods for clean-up:** Allow small spillages to evaporate provided there is adequate ventilation. Do not use water. Ventilate affected area. Isolate leaked material using non-flammable absorption agent (e.g. sand, earth, vermiculit, diatomaceous earth) and collect it for disposal in appropriate containers in accordance with the local regulations (see section 13). Beware of reignition. Thoroughly clean surrounding area.
- Additional information:** Use explosion-proof equipment and non-sparking tools/utensils. Leaking cans, cans with spillage, are to be segregated, sprayed to empty state and disposed of. Refer to section 13 (Waste removal)

7. Handling and storage

Handling

- Advices on safe handling:** Provide adequate ventilation, and local exhaust as needed. Do not breathe gas/vapor/spray. Avoid contact with skin and eyes. Wear appropriate protective equipment. Guarantee sufficient ventilation during and after use, in order to prevent vapour accumulation. Take off immediately all contaminated clothing.
- Precautions against fire and explosion:** Container under pressure. Do not open or incinerate, even when empty. Do not spray into flames or on incandescent objects. Keep away from sources of ignition - No smoking. Take precautionary measures against static discharges. Use only explosion-protected equipment/instruments. Do not weld. In partially filled containers explosive mixtures may form. Vapors may form explosive mixtures with air. Do not pierce or burn, even after use.

Storage

Protect from heat and direct sunlight. Keep at temperature not exceeding 40 °C. Store containers in upright position. Explosion protection required. Store locked up.
