## 7. Handling and storage

### Handling

Advices on safe handling: Provide adequate ventilation, and local exhaust as needed. Avoid the formation of aerosol/vapors. Avoid contact with skin and eyes.

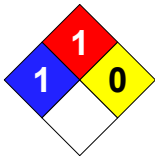
