4. First aid measures

General information: Take off immediately all contaminated clothing and wash it before reuse.

5. Fire fighting measures

Additional information:

Cool endangered containers with water jetspray. In case of fire and/or explosion do not breathe fumes. Do not allow fire water to penetrate into surface or ground water.

6. Accidental release measures

Personal precautions:

Provide adequate ventilation. Do not breathe gas/vapor/spray. Avoid contact with the substance. Eliminate all ignition sources if safe to do so. Wear appropriate protective equipment. Do not open or incinerate, even when empty. Do not spray into flames or on incandescent objects. Be aware that gases can spread at ground level (heavier than air) and pay attention to the wind direction.

Environmental precautions:

Do not allow to enter into ground-water, surface water or drains.

In case of release, notify competent authorities. Danger of explosion!

Methods for clean-up:

Isolate leaked material using non-flammable absorption agent (e.g. sand, earth, vermiculit, diatomaceous earth) and collect it for disposal in appropriate containers in accordance with the local regulations (see section 13).

Beware of reignition. Thoroughly clean surrounding area.

7. Handling and storage

Handling

Advices on safe handling: Provide adequate ventilation, and local exhaust as needed. Do not breathe gas/vapor/spray.
Avoid contact with skin and eyes. Wear appropriate protective equipment. Keep unprotected people away.
Guarantee sufficient ventilation during and after use, in order to prevent vapour accumulation. Take off immediately all contaminated clothing and wash it before reuse.

Precautions against fire and explosion:

Container under pressure. Do not open or incinerate, even when empty. Do not spray into flames or on incandescent objects. Keep away from sources of ignition - No smoking. Take precautionary measures against static discharges.
Use only explosion-protected equipment/instruments. Do not weld.
In partially filled containers explosive mixtures may form. Vapors may form explosive mixtures with air.

Storage

Requirements for storerooms and containers:

Keep container tightly closed and in a well-ventilated place.
Keep container dry. Keep only in the original container.
Protect from heat and direct sunlight. Keep at temperature not exceeding 122 °F.
Store containers in upright position. Explosion protection required. Store locked up.

Hints on joint storage:

Do not store together with combustible or self-igniting materials or any highly flammable solids. Keep away from food, drink and animal feedingstuffs.
